LICENSING ACT 1964

Alcohol (intoxicating) beverages will not be sold to any person under the age of 18 years.

It is an offence for any other person to buy or attempt to buy intoxicating drinks for consumption by a person under 18 in the bar.

This act, if found guilty of doing so, has a £5000.00 fine to both purchaser and licensee.

WEIGHTS & MEASURES ACT 1985

Whiskey, Gin, Rum & Vodka are sold for consumption in measures of 25ml of multiples thereof.

Wine is sold by the glass in measures of 175ml or multiples thereof
